He Kupu Whakataki – Kaupapahere mō ngā Wāhi Petipeti | Introduction – Gambling Venue Policy

Under the Gambling Act 2003 all Councils are required to adopt a Class 4 Gambling Venue Policy and are required to review the Policy every three years.

The Policy can set out how many venues in the district can have pokies at one time, and how many pokies can operate in the district at one time.

The Policy can set where venues with pokies can be located within the district and where they cannot be. Council can ensure new venues with pokies are not close to places like churches, schools, marae or children's playgrounds.

Council can also allow venues with pokies to move to a new venue, or for two venues with pokies to merge and become one venue.

Once Council allows a venue to operate pokies, Council cannot revoke the license. The Department of Internal Affairs (DIA) is responsible for managing licenses once they are granted, including monitoring and enforcement.

Ngā Take mō te Tūtohutanga | Reasons for the proposal

Council reviews its Gambling Venue Policy every three years. During this review, Council identified some parts of the Policy that could change to improve the Policy going forward and make sure it is fit for purpose for our community.

These changes align with the objectives of the Policy, including:

- Controlling the growth of gambling within the district;
- Minimising the harm of gambling; and
- Reflecting the views of the local community in respect of the provision of gambling within the district.

Gambling in Matamata-Piako

In Matamata-Piako, there are currently 140 gaming machines across 10 venues in the District - 4 in Matamata, 3 in Morrinsville, 3 in Te Aroha.

Most venues in the district do not own the gaming machines – they are owned by corporate societies, who pay these venues to have their gaming machines available to play.

Some venues in the district are clubs, like Matamata Club Inc, own their own machines, and can use the gaming machine profits for club purposes (such as maintaining their buildings).

In the case of societies, a portion of gaming machine profits go into a national pool of funds. People or organisations can apply to this pool and receive money in the form of grants.

The current Gambling Venue Policy

The number of gambling venues and pokies allowed – population-based ratio:

Up to 15 venues with pokies may operate in the district at one time in total.

Up to 201 pokie machines may be in the district at one time in total.

There is a cap on the number of venues and machines that are allowed to operate per town:

Town	Maximum number of venues	Maximum number of pokie machines
Matamata	5	80
Morrinsville	4	56
Te Aroha	4	50
Rural	2	15
Total	15	201

Where gambling venues can be located:

Venues applying to operate pokie machines must consult, and get approval from, affected parties within a 250 meter radius of the proposed venue. If there is an objection, a hearing must be held.

It is Council's preference that venues with pokies are in the Business Zone, however this is considered on a case-by-case basis.

Other rules:

Council will consider applications for venues with pokies to move to a new venue under special circumstances. Venues that relocate may have the same number of machines.

Council will consider applications for two venues with pokies to merge and become one venue. Venues that merge may have up to 18 machines or 30 machines (subject to the Gambling Act requirements)

Venues with pokies must have another purpose (e.g. serve alcohol or sports)

Te mānuka e kawea ake ana | What we're proposing:

Ngā panonitanga e tūtohuhia ana | What we're proposing to change:

- Have an absolute cap and remove the population-based ratios.
- Remove the restrictions on the number of machines and venues allowed in each town and apply district-wide restrictions only.
- Venues applying to host pokies must provide evidence in the application that the proposed site is:
 - 100 meter radius away from sensitive sites and;
 - Does not adjoin an existing class 4 gambling venue.
- Update the definitions to include sensitive sites and adjoining.
- Update the Policy to be easier to read.

Ngā mea e tūtohuhia ana kia pūmau tonu | What we're proposing to stay the same:

- No more than 15 venues with pokies may operate in the district at one time.
- No more than 201 machines may operate in the district at one time.
- Ability for venues to relocate under certain circumstances.
- Ability for venues to merge.
- It is Council's preference that gambling venues are only in the Business Zone.

Population-based ratio

A population-based ratio Policy means Council sets a ratio of people to machines per town. As the population increases or decreases, the number of gambling venues and/or pokie machines allowed in the town changes to reflect the population change.

Sinking lid

A sinking lid policy means that once a class 4 gambling venue closes, Council will not issue any other society a license to replace that venue.

Decrease the number of gambling venues and pokie machines allowed

We are proposing to have a cap of 15 venues and 201 pokie machines in the district. This cap could be decreased to allow less venues and less pokie machines in the district.

Increase the number of gambling venues and pokie machines allowed

He Kupu Whakataki – Kaupapahere mō ngā Wāhi TAB | Introduction - TAB Venue Policy

Under the Racing Industry Act 2020, all Councils are required to adopt a TAB Venue Policy. The Policy sets out whether TAB venues may operate in the district and if so, how many may operate and where they may be located.

A TAB venue is a venue which is owned or leased by TAB NZ and where the main business carried out at the premises is the provision of racing betting, or sports betting. There are currently no standalone TAB venues in the district.

Ngā Take mō te Tūtohutanga | Reasons for the proposal

Council reviews its TAB Venue Policy every three years. During this review, Council identified some parts of the Policy that could change to improve the Policy going forward and make sure it is fit for purpose for our community.

- Reflect the views of the local community in respect of the provision of gambling within the district.

The Current TAB Policy

Cap rules

Three standalone TAB venues may be in the district at one time. Only one venue can be established in each of our three main towns. One in Matamata, one in Morrinsville and one in Te Aroha.

Location rules

Venues applying must consult, and get approval from, affected parties within a 250 meter radius of the proposed venue. If there is an objection, a hearing must be held.

It is Council's preference that venues are in the Business Zone, however this is considered on a case-by-case basis.

Ngā Tūtohunga | What we're proposing:

Ngā panonitanga e tūtohuhia ana | What we're proposing to change:

- Applications for standalone TAB venues must provide evidence in the application that the proposed site is 100 meter radius away from sensitive sites.
- Update the definitions to include sensitive sites.
- Update the Policy to be easier to read.

Ngā mea e tūtohuhia ana kia pūmau tonu | What we're proposing to keep the same:

 No more than three TAB venues may operate in the district at one time and there may only be one standalone TAB venue in each of our three main towns.


